- (1). 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。

Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

- (2). 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -

According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

- (3). 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第8 條及附表二第2 部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

(4).(i) 支付條款 Terms of Payment

註：「售價」指本價單第二部份中所列之住宅物業的售價，而「樓價」指臨時買賣合約中訂明的住宅物業的實際售價。因應相關折扣（如有）按售價計算得出之價目，以四捨五入方式換算至千位數作為樓價。買方須為於一份臨時買賣合約下購買的所有住宅物業選擇相同的付款計劃。

"Price" means the price of the residential property set out in Part 2 of this price list, and "purchase price" means the actual price of the residential property set out in the preliminary agreement for sale and purchase. The price obtained after applying the relevant discount(s) (if any) on the price will be rounded down to the nearest thousand to determine the purchase price. The Purchaser must choose the same payment method for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Upon signing the Preliminary Agreement for Sale and Purchase, purchasers should pay an initial deposit equivalent to 5% of the purchase price. Part of the initial deposit in the sum of HK\$500,000 must be paid by cashier order and the balance of the initial deposit may be paid by cashier order(s) or cheque(s). The cashier order(s) and cheque(s) should be made payable to "Mayer Brown JSM" or 「孖士打律師行」.

2.於簽署臨時買賣合約後的五個工作天內須到律師樓簽署正式買賣合約。

The Formal Agreement for Sale and Purchase must be executed within 5 working days after the date of the signing of the Preliminary Agreement for Sale and Purchase.

3.於簽署正式買賣合約時繳付相等於樓價 5%之款額。

A further sum equivalent to 5% of the purchase price is payable upon signing the Formal Agreement for Sale and Purchase.

4.樓價90%（樓價餘款）於簽署臨時買賣合約後90日內繳付。

90% of the purchase price (balance of the purchase price) to be paid within 90 days after the date of the signing of the Preliminary Agreement for Sale and Purchase.

The cashier order(s) and cheque(s) should be made payable to "Mayer Brown JSM" or 「孖士打律師行」.

The Formal Agreement for Sale and Purchase must be executed within 5 working days after the date of the signing of the Preliminary Agreement for Sale and Purchase.

A further sum equivalent to 5% of the purchase price is payable upon signing the Formal Agreement for Sale and Purchase.

90% of the purchase price (balance of the purchase price) to be paid within 120 days after the date of the signing of the Preliminary Agreement for Sale and Purchase.

Basis on which any discount on the price is available

The first 5 residential properties (which must be residential properties sold in accordance with Price List Nos. 1G, 2G or 3F) with the Preliminary Agreement for Sale and Purchase signed will be entitled to a 2% extra discount from the Price pursuant to paragraph 4.(i)(A)5 of this Price List.

Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the development

現金回贈 Cash Rebate

註: (a) 現金回贈只適用於選擇90天付款計劃的物業。

Note: Cash Rebate is only applicable to residential properties subject to the 90-day Payment Method.

(b) 現金回贈只適用於自然人買家，且只適用於簽署臨時買賣合約的買家。現金回贈的優惠不得轉讓。

Cash Rebate is only available to natural person purchaser and to such purchaser who signs the Preliminary Agreement for Sale and Purchase. The benefit of the Cash Rebate is not transferable.

(1) 新從價印花稅現金回贈 Cash Rebate on New Ad Valorem Stamp Duty

首八個需支付及已繳付經<<2014年印花稅(修訂)(第2號)條例>>修訂的從價印花稅稅率計算的從價印花稅（「新印花稅」）的物業（必須為根據價單編號1C、1D、1E、1F、1G、2C、2D、2E、2F、2G、3B、3C、3D、3E或3F所出售之物業），其買方可在買方根據買賣合約完成住宅物業買賣（包括但不限於已繳付所有應繳付的印花稅）後獲賣方提供相等於該物業樓價之4%新印花稅現金回贈（「新印花稅現金回贈」）。獲新印花稅現金回贈優惠的買方必須於完成該住宅物業交易後60天內以書面通知賣方，並向賣方提交所有由印花稅處發出已繳付就正式買賣合約的新印花稅的正式收據，賣方會於收到通知及確認信件並確認有關資料無誤後60天內，將新印花稅現金回贈付予買方。如有爭議，以賣方最終決定為準。

The first 8 residential properties (which must be residential properties sold in accordance with Price List Nos. 1C, 1D, 1E, 1F, 1G, 2C, 2D, 2E, 2F, 2G, 3B, 3C, 3D, 3E or 3F) with the Agreement for Sale and Purchase signed and the purchasers of which are required to pay, and have fully paid, Ad Valorem Stamp Duty ("New AVD") calculated based on the rates of ad valorem stamp duty adjusted by the Stamp Duty (Amendment) (No.2) Ordinance 2014, the relevant purchaser(s) will be entitled to a cash rebate equivalent to 4% of the purchase price of the relevant residential property ("New AVD Cash Rebate") (provided that the purchaser has completed the sale and purchase of the residential property in accordance with the Agreement for Sale and Purchase (including but not limited to payment of all stamp duty payable)). The purchaser who is entitled to New AVD Cash Rebate is required to inform the vendor in writing within 60 days after completion of the sale and purchase of the residential property and to submit to the vendor all the official receipt(s) issued by the Stamp Office evidencing payment of the New AVD on the Agreement for Sale and Purchase. The vendor will pay the purchaser the New AVD Cash Rebate within 60 days after the vendor has received the written notification and all the official receipt(s) of the New AVD from the purchaser and has verified the document submitted by the purchaser. In case of any dispute, the vendor's decision shall be final.

(2) 買家印花稅現金回贈 Cash Rebate on Buyer's Stamp Duty

首三個需支付及已繳付買家印花稅的物業（必須為根據價單編號1E、1F、1G、2E、2F、2G、3D、3E或3F所出售之物業），其買方可在買方根據買賣合約完成住宅物業買賣（包括但不限於已繳付所有應繳付的印花稅）後獲賣方提供相等於該物業的樓價之10%買家印花稅現金回贈（「買家印花稅現金回贈」）。獲買家印花稅現金回贈優惠的買方必須於完成該住宅物業交易後60天內以書面通知賣方，並向賣方提交所有由印花稅處發出已繳付就正式買賣合約的買家印花稅的正式收據，賣方會於收到通知及確認信件並確認有關資料無誤後60天內，將買家印花稅現金回贈付予買方。如有任何爭議，以賣方最終決定為準。

The first 3 residential properties (which must be residential properties sold in accordance with Price List Nos. 1E, 1F, 1G, 2E, 2F, 2G, 3D, 3E or 3F) with the Agreement for Sale and Purchase signed and the purchasers of which are required to pay, and have fully paid, the Buyer's Stamp Duty, the relevant purchaser(s) will be entitled to a cash rebate equivalent to 10% of the purchase price of the property ("BSD Cash Rebate") provided that the purchaser has completed the sale and purchase of the residential property in accordance with the Agreement for Sale and Purchase (including but not limited to payment of all stamp duty payable). The purchaser who is entitled to BSD Cash Rebate is required to inform the vendor in writing within 60 days after completion of the sale and purchase of the residential property and to submit to the vendor all the official receipt(s) issued by the Stamp Office evidencing payment of the Buyer's Stamp Duty on the Agreement for Sale and Purchase. The vendor will pay the purchaser the BSD Cash Rebate within 60 days after the vendor has received the written notification and all the official receipt(s) of the Buyer's Stamp Duty from the purchaser and has verified the document submitted by the purchaser. In case of any dispute, the vendor's decision shall be final.

(4).(iv). 誰人負責支付買賣該項目中的指明住宅物業的有關律師費及印花稅

Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the development

如買方選用賣方指定之代表律師作為買方之代表律師同時處理所有關於買賣的法律文件（如：正式買賣合約、按揭及樓契），賣方同意為買方支付正式買賣合約及樓契兩項法律文件之律師費用。如買方選擇另聘代表律師作為買方之代表律師處理在買賣中行事，買賣雙方須各自負責有關買賣合約及樓契兩項法律文件之律師費用。

If the purchaser appoints the vendor's solicitors to act on his/her behalf in respect of all legal documents in relation to the purchase (e.g. Formal Agreement for Sale and Purchase, Mortgage and Assignment) the vendor agrees to bear the legal cost of the formal agreement for sale and purchase and the assignment. If the purchaser chooses to instruct his/her own solicitors to act for him/her in relation to the purchase, each of the vendor and purchaser shall pay his/her own solicitors' legal fees in respect of the formal agreement for sale and purchase and the assignment.

所有印花稅（包括但不限於從價印花稅、買家印花稅*及特別印花稅*）由買方支付（*如適用）。

All stamp duty payments including, but not limited to: Ad Valorem Stamp Duty, Buyer's Stamp Duty* and Special Stamp Duty* payments will be borne by the purchaser (*if applicable).

(4).(v). 買方須為就買賣該項目中的指明住宅物業簽立任何文件而支付的費用

Any charges that are payable by a purchaser for execution of any document in relation to the sale and purchase of a specified residential property in the development.
