According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, –

## 第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時,該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a Preliminary Agreement for Sale and Purchase in respect of the specified residential property with the owner.

#### 第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約,並於該日期後的5個工作日內,就有關住宅物業簽立買賣合約,則擁有人必須在該日期後的8個工作日內,簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the Preliminary Agreement for Sale and Purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

#### 第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時,但沒有於該日期後的5個工作日內,就有關住宅物業簽立買賣合約,則 – (i) 該臨時合約即告終止;(ii) 有關的臨時訂金即予沒收;及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the Preliminary Agreement for Sale and Purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

## (4).(i) 支付條款 Terms of Payment

The first 8 residential properties (including the residential properties specified in Price List Nos. 1C, 2C and 3B) with the Preliminary Agreement for Sale and Purchase signed and the purchasers of which are required to pay, and have fully paid, the New Ad Valorem Stamp Duty ("New AVD", as set out in the Stamp Duty (Amendment) Bill 2013 gazetted on 5 April 2013, "Bill") chargeable on the Agreement for Sale Purchase, the relevant purchaser(s) will be entitled to a cash rebate equivalent to the specified percentage of the purchase price of the residential property ("New AVD Cash Rebate") (provided that the purchaser has completed the sale and purchase of the residential property in accordance with the Agreement for Sale and Purchase (including but not limited to payment of all stamp duty payable)). Such specified percentage shall be 47.06% of the New AVD applicable to the relevant residential property charged after enactment of the Bill or 4% of the purchase price of the relevant residential property, whichever is the lower. The purchaser who is entitled to New AVD Cash Rebate is required to inform the vendor in writing within (i) 60 days after completion of the sale and purchase of the residential property or (ii) 30 days after enactment of the Bill, whichever is the later, and to submit to the vendor all the official receipt(s) issued by the Stamp Office evidencing payment of the New AVD on the Agreement for Sale and Purchase. The vendor will pay the purchaser the New AVD Cash Rebate within 60 days after the vendor has received the written notification and all the official receipt(s) of the New AVD from the purchaser and has verified the document submitted by the purchaser. In case of any dispute, the vendor's decision shall be final. The New AVD Cash Rebate is only applicable if the enactment of the Bill is not gazetted on or before 31 August 2015 ("Expiry Date"). If the enactment of the Bill is not gazetted by the Expiry Date, the benefit offered under the New AVD Cash Rebate shall be withdrawal automaticall

#### (2) 買家印花稅現金回贈 Cash Rebate on Buver's Stamp Duty

The first 4 residential properties (including the residential properties specified in Price List Nos. 1C, 2C and 3B) with the Preliminary Agreement for Sale and Purchase signed and the purchasers of which are required to pay, and have fully paid, the Buyer's Stamp Duty, the relevant purchaser(s) will be entitled to a cash rebate equivalent to 10% of the purchase price of the property ("BSD Cash Rebate") provided that the purchaser has completed the sale and purchase of the residential property in accordance with the Agreement for Sale and Purchase (including but not limited to payment of all stamp duty payable). The purchaser who is entitled to BSD Cash Rebate is required to inform the vendor in writing within 60 days after completion of the sale and purchase of the residential property and to submit to the vendor all the official receipt(s) issued by the Stamp Office evidencing payment of the Buyer's Stamp Duty on the Agreement for Sale and Purchase. The vendor will pay the purchaser the BSD Cash Rebate within 60 days after the vendor has received the written notification and all the official receipt(s) of the Buyer's Stamp Duty from the purchaser and has verified the document submitted by the purchaser. In case of any dispute, the vendor's decision shall be final. For the avoidance of doubt, any unused quota under the "Cash Rebate on Buyer's Stamp Duty" set out in Price List No.3 and No.3A shall be revoked on the effective date of this Price List No.3B.
